The Invisible Men

We see them all over newscasts and talk shows when they are campaigning but then, as if by magic, the day after they are elected they disappear until it is time to run for re-election or campaign for a different office like, let's say, President of the United States. Who could I be talking about? Representative Pete Sessions and Senator Ted Cruz! Petey and Teddy are both up for re-election in November!

Ted Cruz has come out of his cave twice in the 5½ years since he took the oath of office as a Senator. The first was to show off his literary skills by reading "*Green Eggs and Ham*" to his fellow Senators who were mesmerized by his talent. The second occasion was when Donald J. Trump made him look like an idiot during the presidential debates by calling Ted names and insulting Ted's wife without getting even a grunt for a response.

Pete Sessions is no better. He votes the party ticket 95 to 98 percent of the time and serves on the Rules committee. That's his entire contribution for better government. He collects \$175,000 a year plus perks to participate in one committee. To add insult to injury, there are legitimate questions about whether Pete Sessions lives in Texas or Florida. Tax documents show a home in Texas in Pete Sessions' name and a second home in Florida that appears to be in his wife's maiden name. The six-page, 8 ½ x 11 brochure printed in glossy color we received from Congressman Pete Sessions was mailed as official business and paid for with our tax dollars, is an obvious campaign advertisement with the word DONATE omitted. It lists three corporations that gave employees \$1000 bonuses because of the corporate tax breaks in the "tax reform" law passed recently. That's great, but bonuses are a one time thing and we do not know if all the employees got the \$1000 bonuses or just a select group. Pete claims that same law empowers North Texas families to keep more of your hard earned money.

It's the same old story. The Republicans are buying your vote with your tax dollars while they take their cut to the bank in a wheel barrel. Pete goes on to brag about allowing parents to use their 529 Accounts to save for elementary, secondary, and higher education. See how easy it is? Just put more of your money away. He continues to explain to us how we benefit from the corporate and small business tax cuts. Hopefully some of us do. Pete Sessions brags in a 2016 website that he is a fiscal conservative and deeply concerned about our national debt and yet he voted for and brags about the tax cut bill that will add \$10,000,000,000,000 (that's TEN TRILLION) to the national debt. He boasts about 616,000 jobs created since December 22, 2017, an increase in paychecks, and the lowest unemployment rate in 45 years. Those things are true but the job creation rate is about par for recent times, the wage increase (2.7 percent) barely covers inflation, and unemployment now at 3.9 percent was already down to 4.9 percent when Trump took office.

When teenagers across the country started marching for changes they understood the problem. A pay-for-play congress that either isn't interested in solving problems or doesn't know how to solve our problems. The marcher's solution: vote the deadwood out of office.

Let's make Cruz and Sessions invisible permanently by replacing Cruz with Beto O'Rourke and Sessions with Lillian Salerno!

Salerno's story is compelling

Lillian Salerno is reluctant to contrast her experience with Colin Allred's, so let me do it for her.

Her story is even more compelling. She grew up poor in Dallas, one of nine children, and pulled herself up by her bootstraps and built two businesses. He was the only child of a white single mother who was a schoolteacher.

She worked for over five years in the U.S. Department of Agriculture and was deputy undersecretary of Rural Development for the Obama administration, helping rural areas with innovation and entrepreneurship, managing a \$220 billion bank that serviced the poor. Allred filled in at HUD for less than five months during the transition when Clinton lost.

After building Retractable Technologies in Elm, and fighting off monopolies like Becton Dickinson to get its device to market, she worked to bring her safe needle technology to the world and was involved in the international HIV prevention campaign. He worked for about six months for Battleground Texas during the Wendy Davis campaign.

The Blue Wave may mean anyone can win, but having a person in place with a proven track record who can hit the ground running and not someone who needs "on the job training" will be a huge advantage. Did I say she is a woman?
